4) Privacy Policy

a) Automatic Collection of Non-identifiable Personal Data

Non-identifiable data is collected automatically every time you visit the website (like the web browser you use to enter the website). Such data does not provide information about your identity, but these statistics help PBA to develop the website (identifying the most popular pages, for example).
